

**3M Club Trap and Skeet Club
2022 Club Membership Letter and Registration Packet**

February 5, 2022

Greetings 3M Club Trap and Skeet Shooters!

I would like to announce that the 3M Trap and Skeet club will have a 2022 Trap, Skeet and 5-Stand season. We are planning on a full slate of teams similar to 2019 (pre-pandemic) for Trap and Skeet, pending any restrictions which may be imposed by the 3M Club or 3M Corporate. At this time we do not have exact information regarding social distancing, mask usage or other Covid protocols which we may have to abide by.

Summer Clubhouse Opening: On March 19th weather permitting or March 26th, will be the opening of the Summer Shooting Season, starting at 11am, all club members are encouraged to participate in assisting with clubhouse opening activities. Once all tasks are completed open shooting there is open shooting until 4pm.

Summer Shooting:

To begin the 2022 summer season the range will open at 3:00 PM on Tuesdays and Wednesdays - April 5th and 6th and 12th and 13th - for practice shooting and registered league shoot-ahead rounds. Summer Trap League officially begins on April 19th and 20th and ends in late August.

We are planning on a full 16 week schedule of trap shooting a full 18 week of skeet shooting and a 10 event 5-stand league season (between May 2nd and August 31st)

Important items for 2022:

- How we operate and assemble for shooting may be similar to last year. We will be required to follow 3M Club and 3M Cottage Grove COVID-19 Protocols.
- If we cannot hire trappers for the 2022 season we will have to recruit individuals to assist in operating the ranges. At this time the compensation may be in the form of a shooting card and a box of shotgun shells for every 1 hour block of time. Please let us know if you are interested.
- If we cannot hire trappers additional duties will be assigned to the trap teams besides filling the houses. We truly appreciate your assistance with these tasks.
- If you do not designate which day you prefer your trap team to shoot, your team will be assigned a night to shoot, which should be the same as the night you normally shot for leagues in 2019. Part of our COVID-19 Operational procedures is to have no more than 150 people at the range at any one time.

Lastly, please honor the policy that teams cannot begin loading trap houses until after 7:30 pm or when most trap shooting is complete. A team trap loading schedule will be released prior to the summer league season with guidelines on loading quantities.

High School Participants: The 3M Trap & Skeet Club continues to promote and support the sport for our youth and as a consequence we will again balance our calendar to allow high school students to utilize our facility. Last season Club members donated over \$1000 to support the fastest growing High School sport and it was well received by the teams. Please continue to support this endeavor with your donation located in the Registration packet. Teams will shoot on Sundays and Mondays.

Practical Shotgun: Back by popular demand, the Practical Shotgun events will return. Details to follow in March.

3rd Annual 3M 100 Trap Shooting Event: Scheduled for August 30-31 more info to follow.

Fall Open Shooting: The 2022 season ends with Fall Open Shooting beginning Sunday, September 11 from 12:00 PM to 4:00 PM and on each Sunday thereafter until October 23. This is also the day we closedown and winterize the summer clubhouse. If the club elects to have open winter shooting in 2022 we will move the necessary items from the summer club house to the bird house.

Annual 3M Trap and Skeet Club Banquet and Awards: Scheduled for September 15 at the VFW Red Barn, Cottage Grove. Invitations will be sent to members as event gets closer.

The Board of Directors encourage and appreciate all registrants to fill in at least one box according to your volunteer strengths and talents. Please complete all sections in which you wish to participate, ending with your signature and the date.
- Individuals who wish to join the 3M Club Trap & Skeet Club are not obligated to join a league. You can be a member and shoot trap, skeet or 5-stand clays at your leisure outside of league shooting.
- Summer league Trap, Skeet and 5-Stand Clays registrations are due on or before March 25th, 2022.
- **The club encourages you to have your 2022 registration form and waiver submitted by the March 25th deadline.**
- You can make a donation to help support the MSHSCTL Cottage Grove and Hastings high school trap teams shooting at the club this year. You will find the donation line at the end of the 2022 registration form.

This registration will be e-mailed to all recent club members of record with a valid e-mail address. Paper copies will be sent through the U.S. Mail to members without an internet address.

The 3M Trap & Skeet Club now e-mails registration forms, banquet invitations, and other correspondence to its club members. Therefore, please provide your current e-mail address when registering. FAMILY MEMBERS:

To qualify as a family member in the 3M Trap & Skeet Club, the shooter must meet one of the following criteria:

- Be a spouse of a 3M Employee or 3M Retiree
- Be a dependent child under the age of 21 or a full-time student under the age of 25 living at home with the 3M Employee or 3M Retiree.

If a shooter does not meet one of the above criteria, and is not a 3M Employee or 3M Retiree, he or she will be considered a guest member of the club.

GUEST MEMBERS:

The 3M Club requires the 3M Trap & Skeet Club to continually monitor its guest membership to assure it meets the requirement that the ratio of 3M Employees/3M Retirees to guest members ratio is 1:1 or greater. 2022 guest members need to return their registration form by March 25 to maintain their guest membership for 2022. If it becomes necessary, the club will queue up registration forms on a first-come first-serve basis for new 2022 guest members and 2021 guest members who submitted their registration AFTER the March 25th deadline.

3M CLUB TRAP AND SKEET CLUB

TRAP, SKEET CLUB and 5 STAND - GUN SAFETY RULES & ETIQUETTE

1. Members of the Board of Governors (TRAP, SKEET and 5 STAND Directors and other club officers) will act as Range Safety Officers. These personnel have the right to dismiss any individual from the shooting range for unsafe actions and have the authority to close the fields upon determination of unsafe shooting conditions.

2. SKEET and 5 Stand - No gun will be loaded until the shooter is on the shooting station and ready to call a target.

3. TRAP - Loading the Gun: The placing of a single live round into the chamber (two for doubles trap) is allowed when...

- a. There is not an active "cease fire" called or in progress.
- b. There is no one down field in the line of fire and the orange cone or other designated "cease fire" indicator has been removed from the trap house.
- c. A score keeper is present, ready, and located behind the shooters.
- d. All shooters are standing prepared at their proper station.

4. TRAP – Closing the Action: Young age and/or newer shooters are encouraged to not close their actions until it is their turn to shoot. This is consistent with high school trap shooting rules. A young shooter must have a hunter's safety card and be ready to show it upon request. Also young shooters are required to have an experienced older shooter present on the field at the time of the event.

5. An experienced shooter may close his/her action containing a live round at any time when...

- a. When item 2 (in the case of Skeet and 5 Stand) and/or 3 (in the case of TRAP) are satisfied.
- b. The squad is actively shooting targets.
- c. The shooter still has a need to fire from that station.
- d. The barrel is kept in a downrange orientation (not straight down, not horizontal)
- e. The closing of the action is timed so as not to disrupt other shooters.

These requirements are consistent with ATA rules.

6. A shooter shall in no manner interfere with the preceding shooter or otherwise create an observable distraction on the line. This means:

- a. Do not begin raising your gun until the preceding shooter has fired,
- b. Do not pick up shells from a box on the ground. Use a vest, shell bag or a box holder.
- c. Shooting a semi auto shotgun can cause a distraction by launching spent shells into your nearest neighbor on the trap line. A shell catcher attached to the receiver (may be a simple rubber band, carry extra they break) is **STRONGLY** recommended.
- d. SKEET – No member of a squad having shot from one station shall proceed toward the next station in such a way as to interfere with another shooter. It is recommended for the courtesy to team members, that shooters do not advance more than one-third of the way to the next shooting station until all shooters have completed the station.

7. When changing from station to another station in TRAP, SKEET or 5 STAND, guns must be unloaded and actions open. Also, it is recommended the TRAP or 5 Stand shooter moving from station 5 to station 1, rotate to the right and proceed to station 1 behind the other squad members. This will prevent injury to the following shooter and possible damage to expensive shotguns.

8. When not on a shooting station, all guns must be carried with the breach or action opened.

9. When loaded (TRAP, SKEET and 5 STAND), the gun must always be pointed in a direction that will not endanger anyone. Always ensure that trap personnel are not in the line of fire.

10. TRAP - If a delay in shooting or a "cease fire" (e.g., trap house problems or there is expected an extended delay) event occurs, the shooter must open his/her gun, extract all shells and place the shotgun in the rack provided. Trappers will control this situation by asking shooters to rack their guns. When the problem has been resolved, the trapper will call for return to stations.

11. TRAP - No persons other than shooters and trap operators are allowed on field during shooting. If requested, an experienced shooter will be allowed on the field to help individual/new shooters with shooting advice. Experienced shooters will check in with the trapper and state their intent.

12. SKEET – During the shooting of single targets, a shooter may load two shells except at station 8 high house or for the last singles target on any station.

13. 5 STAND, no more than two shells may be loaded at any time. If two shells are loaded for the initial single target at a station and only a single shot is taken, the shooter must remove the remaining shell from their gun before the next shooter in line calls for a target.

14. No extra shots, in TRAP, SKEET or 5 STAND will be taken at the end of or between rounds.

15. Shot shell requirements. A shooter must use shells that conform to the values in the table below.

Shot Weight Max	Muzzle Velocity
7/8 oz	1350
1 oz	1325
1-1/8 oz	1290

These velocities are maximum, and no individual shot shell shall exceed these limits for the designated shot charge. In addition, no load containing more than 1-1/8 ounces or any shot larger than Number 7-1/2 can be used. Most commercially available factory loads publish this information on the box.

16. After experiencing a misfire, do not open the action immediately, wait ten seconds, while pointing the gun down range before opening the action. Open action and place misfired shell on the ground in front of your shooting station, upon completion of your 25-shot round, pick up the shell. We no longer have a 'dud' bucket at the club. Take the misfired shell home and carefully dismantle and disposed of it properly.

17. Empty hulls may not be picked up while on the firing line, in TRAP and SKEET. Casings must be picked up at the end of the round after all guns have been cleared.

18. All persons (including shooters, scorers, and trap personnel) must wear eye and hearing protection on all the TRAP, SKEET and 5 STAND ranges while shooting is in progress.

19. In YARDAGE TRAP, there shall be no more than two (2) yards difference between adjacent shooters, and no more than a total difference of three (3) yards between any two members of a squad.

20. Bad Weather: Due to lightning or other unsafe weather condition, a league session may be called by a board member or the range manager/cashier. Make up rounds must be shot the next week on your regular shooting day. Scores must be put on the bad weather sheet.

21. For more comprehensive rules Information, please consult the Rules and Regulations Books for TRAP – ATA, SKEET – NSSA and SPORTING CLAYS/5 STAND.

Remember: Safety is everybody's responsibility! A gun is unforgiving and rarely gives a second chance!
